CLOSURE OF THE OWN SHARES PURCHASE PLAN

28 October 2008 – Exprivia announces that on 26 October 2008 concluded the plan for the purchase and disposal of own shares pursuant to Articles 2357 and 2357-ter of the Civil Code approved by the Ordinary Shareholder Meeting on 27 April 2007.

As described in the press release of 26 March 2006, the **main motivations** of the plan to purchase and disposal of own shares were linked in any acquisition or equity participation, action on the stabilization of the title listed, stock option plans and operations for trading in compliance with Article 1 of the 2357 Civil Code.

In the period from **27 April 2007** to **31 December 2007** were purchased 57,000 own shares for a total book value of Euro 99,596.57 and were sold the same 57,000 shares at a price of Euro 141,252.72.

In the period from **1 January 2008** to **26 October 2008** were purchased a total of 369,247 shares for a total book value of the Euro 372,545.23 and were sold on the market 6000 shares at a price of Euro 4,440.

On the date of the closing of the plan to purchase and disposal of shares, the company therefore holds in the portfolio 363,247 shares with a total value of Euro 368,105.23.

All operations of purchase and disposal have been carried out on the market MTA - Star of Borsa Italiana in order to stabilize and support the exchange rate of Exprivia title.
