FIRST SECOND-LEVEL COMPLEMENTARY CONTRACT LAUNCHED BY EXPRIVIA

Numerous measures including introduction of the "performance bonus" and a better work-life balance for employees

3 January 2019. Performance bonus, flexible working hours, continuous training. This year sees the launch of the agreement on the second-level complementary contract, signed in November by **Exprivia S.p.A.**, **Exprivia|Italtel** group companies and trade union representatives.

Affecting all 1,700 direct employees of the company, the agreement was acceptable to 90% of the company workforce as expressed through a referendum.

The measures have a three-year validity, expected to end on 31 December 2020, and envisage:

- a Performance Bonus, subject to certain company profit level indicators being reached, for a per capita amount of up to EUR 800 per year - potentially increasing for years after the first - that the employee can choose to convert into welfare services and/or company shares;
- improvements to the current business travel allowance;
- increased flexibility in the times for starting and finishing work and a longer lunch break, allowing professional commitments to be balanced with personal needs. This measure is in addition to the smart working initiative already in operation.

Lastly, the agreement envisages the setup of trade union coordination for contact with company management to discuss issues relating to professional training, HR enhancement and equal opportunities, welfare, smart working, health, safety and the environment.

Domenico Favuzzi, Exprivia Chairman and CEO, said: "ICT sector companies depend heavily on the quality and commitment of their human resources and their ability to adapt to the strong transformation in progress. The complementary contract just signed represents the initial step in better sharing of company objectives with all our employees. The key element of the contract signed is without doubt the Performance Bonus, a measure that involves the entire company workforce in achieving the company objectives in the business plan presented last July. With everyone's commitment, in fact, facing the challenges we have now will be more stimulating and gratifying. In addition, we aim to create a working environment that is not only dynamic, but also more serene, where everyone can feel more stimulated to grow as an adult and professionally."
