

NOTICE REGARDING THE COUPON RATE ON THE BOND DENOMINATED "EXPRIVIA S.P.A. - 5.80% 2017-2023"

Exprivia S.p.A. - a company listed on the STAR segment of Borsa Italiana [XPR.MI] - with registered office in via Adriano Olivetti 11, Molfetta (BA), announces that the NFP / EBITDA parameter reported on the Management Pro Forma Consolidated at 31 December 2019 relating to the Issuer's Group, as defined in the Loan Regulations, was 2.5, lower than the limit of 3.0; for this reason, in accordance with Art. 7 of the Loan Regulation, the annual interest rate for the period from 14 December 2019 to 14 December 2020 is reduced from 5.80% to 5.30%.

Therefore, the coupon rate on the bond denominated "Exprivia S.p.A. - 5.80% 2017-2023" ISIN code IT0005316382 of nominal Euro 23,000,000.00, quoted on the ExtraMOT PRO market, which will be paid on June 15th 2019, will have the following feature:
