POSTE ITALIANE ENTRUSTS THE MANAGEMENT OF ITS ERP SYSTEMS FOR THE ADMINISTRATION, FINANCE AND CONTROL DIVISION TO EXPRIVIA

The overall value of the commission for Exprivia will be around €5.3 million, consolidating its role as the reference supplier for the Poste Italiane Group

1st August 2017. **Exprivia** - a company listed at the Borsa Italiana Stock Exchange [XPR.MI], heads an international group able to enable digital transformation technology through solutions that involve the entire value chain - following the awarding of a tender concerning the management of information systems in the Administration, Finance and Control Area of **Poste Italiane** based on an SAP platform, signed a contract covering the four-year period from 2017 to 2021.

The assignment concerns the management and development of information systems to support the Administration, Finance and Control, Purchasing and Warehouse, Sales, Invoicing, Property Management and Reporting processes for Poste Italiane and the companies within the Group.

The commission, awarded to a temporary consortium with a primary economic operator, has an overall value of around €7 million, €5.3 million of which will be received by Exprivia, and a duration of 4 years. The project concerns the progressive maintenance of around 20 application systems used by approximately 10,000 users.
