The sixth largest private company in Italy by revenue and a medical centre of excellence on the Italian healthcare scene employing over 2,000 people in Lombardy and other regions of Italy, the MultiMedica Group has chosen the Exprivia 'RIS-PACS' integrated system, which enables X-ray images to be used at different facilities from the one where the clinical diagnostic activity was carried out and to be shared by all the group's hospital departments and outpatient departments, in full compliance with the privacy laws.

The system produced by Exprivia Healthcare IT, the company in the Exprivia group that produces solutions for the healthcare sector, enables the radiology system and the image filing and transmission system to be integrated in a cloud, thus contributing to the **complete dematerialization of clinical images** and ensuring a reliable retrieval system. In addition, the Exprivia software solution can receive any other type of health data, including reports, films and tracings.

As the technological infrastructure is external and not local, the MultiMedica Group has obtained significant operational savings, benefiting also from much shorter design start-up times than those necessary for a traditional installation.
