Aware of the importance of safeguarding and protecting the environment, as it firmly believes that the quality of the environment affects the quality of life and economic development, Exprivia has decided to comply with the UNI EN ISO 14001 standard voluntarily, defining and implementing an Environmental Management System compliant with the requirements of said standard. Exprivia has also decided to implement the environmental system with the energy management system, as energy performance is a crucial element integrated into the concepts introduced by environmental management. This is why Exprivia has started from the subsidiary company, Exprivia Projects, to implement an Energy Management System,

Therefore, to clarify its environmental responsibility, company management has drafted its Environmental and Energy Policy and made it available to the public, customers, and all interested bodies. Demonstrating its environmental and energy commitment translates into:

- Operating in compliance with all laws, regulations and standards applicable in the environmental and energy sphere;
- Constantly safeguarding the environment from the performance of its production processes and the use of the company's infrastructures and structures that are necessary for the above processes;
- Keeping company staff informed, trained and up-date to favour environmental responsibility and awareness and proactively involve them in the implementation and improvement of the environmental and energy management system;
- Monitoring and assessing the environmental impacts generated when performing its activities, understanding the effects and identifying the causes, with a view to continuous improvement and prevention of environmental pollution;
- Assessing in advance the potential environmental effects of new processes and/or significant changes made to those already existing;
- Continuously improving the Environmental and Energy Management System to improve the company's environmental and energy performance;
- Provide a framework for setting and reviewing energy objectives and targets
- Commit to ensuring the availability of information and resources needed to achieve energy objectives and targets
- Support the procurement of energy-efficient products and services that impact energy performance
- Support design activities that look at improving energy performance

Within the sphere of their work activities, all employees are constantly informed, trained and made aware of the effect that their job may have on the environment and energy. Therefore, each worker is required to pursue, within their responsibilities, the objectives the organisation has established and that are listed below:

Optimal waste and waste water management, aimed at ensuring that waste products are reduced, recycled
